### **Opening Prayer**

- Opening Prayer was given by Fr. Ken
- April Meeting Minutes a motion to approve was made by Tonya and seconded by Gary. The Minutes were approved
- Old Business
  - a. Grant/Loan~ Paycheck protection plan
    - i. \$238,000 received with the stipulation to spend it in 6 weeks
    - ii. Becomes a Grant if at 75% is spent on salaries and 25% spent on mortgage interest and utilities
    - iii. Should be able to use all of the money for the indicated expenses
- After Quarantine is over/Preparations
  - **a.** Father participates on the Diocese committee on operations and recommendations for churches during the pandemic
  - b. Upcoming communication on other counties. Polk county will continue with no masses
  - c. Once Phase I begins for weekday masses, there will be specific regulations to follow such as:
    - i. spray down pews in between masses
    - ii. ministers required to wear masks. Masks for Parishioners recommended
      - 1. Cloth masks may be provided by the church
    - iii. No children servers
    - iv. No music and no books in the pews
  - d. Church has large amount of cleaner and hand sanitizer. More will be needed once reopen
  - e. Example of a communication sent by Sacred Heart was discussed. Father will work with Vicki to develop a similar communication

#### Sacraments

a. First Communion may possibly be in July or August

- b. There may be a limit on number of people allowed to attend.
- c. Father is allowed to perform Confirmation
- d. These Sacraments will be done this year and not moved to combine with next year's students
- e. An update was sent to the students/families on May 6th from Pete Hack

#### New Business

- a. Committee Updates
  - Welcome Committee visits have been suspended until after the quarantine has been lifted
  - ii. Social Concerns Committee next meeting at the end of May
    - 1. Tithe of Tithe and the Ankeny summer lunch program has been suspended
    - 2. Catholic Worker House lunch still happening using "to go" containers

## iii. Liturgy Committee -

- 1. Reviewed activity from Lent and On-Line services
- 2. The holy day, Ascension, has been moved to Sunday May 24th
- 3. Once we are able to return to mass, St Luke's needs a quality camera to broadcast into the gym. Will ask parishioners if anyone has a camera for the church to borrow
- 4. Liturgy committee is looking into how to get more involvement with kids. Possible Zoom meetings

### **b.** On-Line Faith Formation

- i. Father will be doing more FaceBook/YouTube talks
- ii. Bishop Barron's, Word on Fire
- iii. Sadler Deacon Matt
- iv. Need to find ways to communicate these On-Line options to parishioners
- v. A discussion was held concerning music and need to obtain the copyright
- c. Letter from Jimmy Becker generated many questions from the parishioners
  - i. Requested that the Parish Council be given prior notice of efforts like this
  - ii. Letters in this effort were only sent to parishioners who had agreed to share their name and address in the parish directory
- d. Parishioner requests for Eucharist

i. The Eucharist can only be distributed within the sacrament, such as during mass or anointing of the sick

### • Father Ken's comments

- **a.** Building Looking to gather bids for subcontractors as many contractors are looking for work and this may help to get a better price. Currently have estimates only and no real bids
- **b.** School the teachers have gone above and beyond to educate the children during the quarantine
  - i. Offers have been made for the PE and Art teacher. The Art teacher will be a shared position with St. Joseph and Holy Trinity.
  - ii. The \$3400 tuition assistance was accepted by OLIH
- c. Budget updates The Loan/Grant will help the budget immensely
