It can be purchased for Halloween. \$19.50 is what we pay for a case. We have not yet set a price for a case. Maybe \$50 which is cheap for this amount of candy for Halloween. We have 18 cases. Ryan proposed that we sell them for \$50. Moved by Mike R. Seconded by Dave C. Motion passed.
- 2. Christmas Wreath Sales Thanks to Steve W. for lining up the sales. The officers discussed selling 160 which need to be ordered by November 1<sup>st</sup>. The budget has 160 wreaths. Up in price to \$25 each this year, with slightly more if the wreath is delivered. We will do sales after Nov 6, 13, and 20 after each of the masses. Wreaths will be delivered to us on November 20<sup>th</sup>. Steve will need help to prepare them at that time, and get the delivered ones to the purchasers. Steve W. will set up Knights to sell after masses on the 3 weekends.
- 3. Council Directory: The question was posed if we should add the wife's name to go with the Knight's: Thought this would be a nice touch. Jason needs to run this by Mike G.
- 4. Brick Purchase: Officers considered having the council purchase a brick that goes in the prayer garden that is being built at this time. Jason proposes that the Council buy an 8 by 8 brick with our council name and Knights symbol. Bruce M. made motion, and Steve W seconded the motion to buy the brick. Could add the year that our council was formed if space allows. Good idea. No other discussion. Vote passes.
