RaiseRight™

Formerly ShopWithScript

St. Luke the Evangelist Catholic Church & School (referred to herein as “we”, “us”, and “our”) sponsors a RaiseRight program which allows you to purchase RaiseRight. The RaiseRight you purchase through our program generates rebates from the participating retailers. These rebates can be used as a credit to your tuition account, a gift to the school, or as cash back to you. The parties agree as follows:

1. **In order for you to participate in the rebate program, a minimum of \$2,500 of gift cards must be purchased each calendar year.** Otherwise, 100% of the rebate will be given to the St. Luke’s School General Fund or St. Luke’s Building Fund, to be determined by the St. Luke’s Finance Council.
2. 50% of Rebates earned will be kept in the RaiseRight program to cover expenses and purchase inventory. We may choose to periodically move some of these funds to the School General Fund or the St. Luke’s Building Fund at the discretion of the St. Luke’s Finance Council.
3. The remaining 50% of Rebates earned will be used in the following way (please ‘X’ only ONE):
 - a. _____ as a charitable contribution to the church building fund
 - b. _____ as tuition credit* to my family’s tuition account
 - c. _____ as tuition credit* for the following school family: _____
 - d. _____ as tuition credit* for a school family in need as determined by the school
 - e. _____ as cash rebate to you

**Note: Due to the timing of the RaiseRight rebate process, tuition credit will only be applicable to families paying their tuition in monthly installments. If you don’t qualify, you can select cash and still get the same value.*

4. Our RaiseRight program distributes the rebates one time per year in the month of December. **The cut-off date for purchases is DECEMBER 31 of the current year. If you did not purchase the minimum requirement as noted in #1 by this cut-off date, no rebate will be issued.** School Tuition Credit will be applied first to any past due tuition, fees, etc., then to next semester’s tuition.
5. With respect to your charitable contributions, we will provide you with all required acknowledgements under section 170(f)(8) and 170(f)(17) of the Internal Revenue Code. Distributions will be made in the month of December based on purchases through the cut-off date. **Again, if you did not purchase the minimum requirement as noted in #1 by the cut-off date, no credit toward a charitable contribution will be given.**
6. You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover the checks or ACH transfers you issue to pay for your RaiseRight. We make no representations or warranties of any kind with respect to the RaiseRight. This agreement continues unless replaced by another, and can be terminated by either of us upon 60 day’s advance notice to the other.
