



St. Luke the Evangelist Catholic Church & School (referred to herein as "we", "us", and "our") sponsors a RaiseRight program which allows you to purchase RaiseRight. The RaiseRight you purchase through our program generates rebates from the participating retailers. These rebates can be used as a credit to your tuition account, a gift to the school, or as cash back to you. The parties agree as follows:

1. In order for you to participate in the rebate program, a minimum of \$2,500 of gift cards must be purchased each calendar year. Otherwise, 100% of the rebate will be given to the St. Luke's School General Fund or St. Luke's Building Fund, to be determined by the St. Luke's Finance Council.
